Atleast one member of the committee should be from reserved category, the committee will make recommendations to the principal based on observations and examination of the complaints

- Based on the committee's recommendation, the Principal shall give the final decision. The principal may further call for an enquiry committee, if required, for further examination of such complaints
- The committee will follow relevant acts and rules of Govt of India and court orders, etc as applicable from time to time
- The Committee shall decide whether the facts contained in the complaint make out a case of "category grievance"
- The Committee shall look into the truth of the allegations contained in the complaint
- The Committee shall recommend the penalties / action to be taken against any person found guilty of having harassed the complainant, up to and including termination
- The Committee shall recommend appropriate psychological, emotional and physical support (counseling, security and other assistance) for the victim to the Management
- The Committee shall monitor the follow-up action to be taken by the Management on receipt of the Report of the Committee.


