- To ensure implementation of laid down procedures including the constitution of appropriate committees for purpose of gender sensitization and to conduct enquiries into complaints of sexual harassment
- To recommend punitive action against the guilty to the Principal.
- To fulfill the directive of the Supreme Court of India enjoining all employees to develop and implement a policy against Sexual harassment of women and men at work place.

Scope:

The policy is applicable to all employees and students (females & males) and also to the

third parties associated with SIORCOP.

The third party would include the patients, their relatives/attendants, volunteers, trainees

and visitors etc. who are associated to the Organization.

The committee will have representation of the members from across all staff cadres.

Function:

The Committee shall decide whether the facts contained in the complaint make out a case

of "sexual harassment" in light of the definition contained in the Policy.

The Committee shall look into the truth of the allegations contained in the complaint.

The Committee shall look into the truth of any allegation of retaliation against /

victimization of the complainant or any other person assisting her as a result of such

complaint having been made or such assistance having been offered.

The Committee shall recommend the penalties / action to be taken against any person found

guilty of having sexually harassed the complainant, up to and including termination.

The Committee shall recommend the penalties / action to be taken against any person found

guilty of having retaliated against / victimized the complainant or any other person assisting

her as a result of such complaint having been made or such assistance having been offered.






